

- 1. The specific rules set out in these Terms & Conditions shall be incorporated into the Competition Rules ("Rules") which shall apply to the Promotion. A printed copy of the Rules can be obtained by sending a stamped addressed envelope to: Marketing Department, Bosch Thermotechnology Limited, Cotswold Way, Warndon, Worcester, WR4 9SW stating the name of the Promotion. By entering the Promotion, entrants agree to be bound by these Terms & Conditions and the Rules. In the event of a discrepancy between these Terms & Conditions and the Rules, these Terms & Conditions shall prevail.
- 2. The promoter is Bosch Thermotechnology Limited, a company incorporated in England and Wales with company number 01993294, whose registered office is Cotswold Way, Warndon, Worcester, WR4 9SW United Kingdom ("Promoter").
- **3.** Employees of the Promoter, or any other company within the Bosch group of companies (including BSH Home Appliances Limited), and their immediate family members, Bosch's agents, authorised retailers or their employees, or any person professionally associated with this activity (or members of their family or household) may not participate in the Promotion.

## To be eligible to participate in the Promotion

- **4.** The Promotion will commence on Monday 4th April 2016 and close on 31 December 2016 (**"Promotional Period"**).
- 5. The Promotion is open to non-Worcester accredited installers who are Gas Safe Registered and are resident in England, Scotland and Wales (an "Eligible Participant"). The Promotion
- is not open to residents in Northern Ireland or the Republic of Ireland. You will not be eligible to enter the Promotion if you are a merchant, specifier, contract customer or consumer.
- **6.** You will not be eligible to enter the Promotion if you are a Worcester accredited installer.
- 7. The Promoter assumes that by using the website and/or entering the Promotion (and you warrant that) you are aged 18 or over.
- 8. If you are entering the Promotion as an employee of an organisation then you have an obligation to (i) inform your employer about the Promotion, and (ii) obtain the permission of your employer to enter the Promotion.

# **Qualifying Product**

- **9.** To be eligible to claim the Rewards (as defined in paragraph 12), an Eligible Participant must:

- 9.1.6 Greenstar 18i System;
- 9.1.7 Greenstar 21i System;
- 9.1.8 Greenstar 24i System;
- 9.1.9 Greenstar 25Si Compact;
- 9.1.10 Greenstar 30Si Compact;
- 9.1.11 Greenstore Unvented Cylinder; or
- 9.1.12 Greenstore Solar Compatible Unvented Cylinder

# (each a **"Qualifying Product"** and together the **"Qualifying Products"**); and

**9.2** register the manufacturer's guarantee of the relevant Qualifying Products at https://www.worcester-bosch.co.uk/professional /reward-programme/guarantees, by the end of the Promotional Period (together the **"Entry"**).

**Note.** Any Worcester products purchased and installed during the Promotional Period may be registered via the rewards programme website stated in paragraph 9.2. However, only those Qualifying Products listed in paragraph 9.1 will qualify for reward points which can be used to claim the Rewards (as defined in paragraph 13).

- 10. One Entry will provide the Eligible Participant with 10 points for a boiler (paragraph 9.1.1 - 9.1.8) or 15 points for a compact boiler (paragraph 9.1.9 and 9.1.10) or 5 points for a cylinder (paragraph 9.1.11 and 9.1.12).
- **11.** The Promotion only applies to Qualifying Products which have been supplied and distributed by the Promoter within the United Kingdom and the Republic of Ireland. The Promoter will not accept any Qualifying Products that are purchased from alternative markets.
- **12.** The Promotion is not available on any second hand or graded stock.

# The Reward

  - **13.9** Worcester ACS Training Course;
  - 13.10 Worcester OFTEC Training Course; or
  - **13.11** Worcester Unvented Training Course,

## (each a "Reward" and together the "Rewards").

**14.** The Reward that the Eligible Participant is able to claim will be determined by the number of points accrued. The amount of points an Eligible Participant will need to claim per Reward is as follows:

- **15.** The Reward is not transferable and there is no cash alternative. The Promoter reserves the right to substitute the Reward with product(s) of equal or greater value at any time.
- **16.** The Reward or any promotional item(s) must not be auctioned or resold. The Promoter reserves the right to refuse to accept further entries under the Promotion if it becomes aware of the reselling or auctioning of the Reward or any promotional item(s).

# How to claim the Reward

- 17. To claim the Reward, the Eligible Participant must log in to their reward account ("Account") found at https://www.worcesterbosch.co.uk/professional/reward-programme and select the Reward of their choice (the "Claim") before the 31 January 2017 ("Closing Date"). The Eligible Participant will not be able to select Rewards for which they have insufficient points.
- **18.** The Promoter will arrange for the Reward to be delivered to the Eligible Participant at its own cost within 28 days of the Claim to the address stated on the Account.
- **19.** The Eligible Participant may make as many Claims as it wishes before the Closing Date provided they have sufficient number of points.
- **20.** The Promoter cannot accept responsibility for delayed or incorrectly submitted entries, or Claims which are not submitted via an Account.

#### General

**21.** A Reward will be only awarded to an Eligible Participant in his professional capacity and is awarded for business use only.

- **22.** In all matters relating to the Promotion, the decision of the Promoter shall be final and no correspondence or discussion shall be entered into.
- **23.** At all times throughout the Promotion, the participant must deal with the Promoter in the utmost good faith in every respect. The Promoter reserves the right to verify the eligibility of all participants and disqualify any participant that it has reasonable grounds to believe has breached information submitted to or requested by the Promoter.
- **24.** The Promoter reserves the right to amend or terminate the Promotion at any time without notice. However, the Promoter will use its reasonable endeavours to minimise the effect of such amendment or termination to avoid disappointment. Any termination or amendment to the Promotion will be notified to you at https://www.worcester-bosch.co.uk/professional/rewardprogramme.
- **25.** The Promoter does not claim any rights of ownership in your entry, nor does the Promoter accept responsibility for the return of any entry, including those consisting of artistic or other material.
- **26.** The Promotion cannot be used in conjunction with any other promotions that are run by the Promoter or any company within the Bosch group of companies
- **27.** The Promoter excludes all liability for taxes relating to the Reward and any tax liability arising from the provision of the Reward will be the sole responsibility of the Recipient of the Reward.
- **28.** You may be requested to take part in promotional activity and the Promoter reserves the right to use the names and addresses of the participants and their businesses, their photographs and audio and/or visual recordings of them in any publicity.
- **29.** The Promotion does not put an obligation on any participant to purchase products from the Promoter or purchase products from any other company within the Bosch group of companies in value or in volume to the extent that it is not lawfully permissible. The Eligible Participant should only install the Promoter's products where doing so is in the best interests of the end customer and regardless of the Promoter recommends that the Eligible Participant makes the end customer aware of the Promotion before they have made an Entry.
- **30.** The Promotion will be governed by the laws of England and Wales and the courts of England and Wales shall have the exclusive jurisdiction to settle any dispute or claim arising out of or in connection with the Promotion.
