Extended Guarantee Promotion ("Promotion")

Terms & Conditions



- 1. The specific rules set out in these Terms & Conditions shall be incorporated into the Competition Rules ("Rules") which shall apply to this Promotion. A printed copy of the Rules can be obtained by sending a stamped addressed envelope to:
