

## Technical Bulletin

Installation: Bosch CS2000AWF heat pump clearances update


There have been some questions raised regarding the allowed clearances in front of the CS2000AWF heat pump unit. The installation manual states that there should be a minimum clearance of 3000mm to the front of the unit in all outputs (section 5.2: figure 15), but after consultation these clearances can be reduced to that shown below (section 5.3.1: figure 17).

Even though the diagram shows the unit front fascia facing a wall (for cases of high winds), these distances are still relevant when the unit is set normally with the rear of the unit set towards the wall. All side and rear clearances still must be adhered to during installation. Also, the clearances when cascading the units have been updated as shown below. The installation manual will be updated in due course.


## **Overview**

- CS2000AWF 4 to 6 kW:- (minimum clearance to the front) 3000mm to reduced to 1000mm
- CS2000AWF 8 to 16 kW:- (minimum clearance to the front) 3000mm to reduced to 1500mm
- CS2000AWF 18 to 30 kW:- (minimum clearance to the front) 3000mm to reduced to 1500mm


